



Memphis City Council Summary Sheet

Resolution to accept grant funds from the State of Tennessee Department of Labor and Workforce Development

- This item is a resolution to accept grant funds from the State of Tennessee, Department of Labor and Workforce Development in the amount of \$386,991. These funds will be used to reimburse WIN for space and access/applications made available to Employment Security staff at the Career Centers in Downtown, Memphis (Shelby County) and Somerville, TN (Fayette County).
- The State of Tennessee Department of Labor and Workforce Development allocated these funds to the Workforce Investment Network based on resource sharing cost estimates, updated annually.
- This is a new grant award, pending council acceptance.
- Acceptance of these funds will require a new contract between the State of Tennessee Department of Labor and Workforce Development and the Workforce Investment Network/City of Memphis.
- Acceptance of these funds will require an amendment to the FY2012 operating budget to appropriate the funds.

RESOLUTION

WHEREAS, the City of Memphis Workforce Investment Network has received grant funds in the amount of Three Hundred Eighty-six Thousand, Nine Hundred Ninety-one Dollars (\$386,991.00) from the State of Tennessee Department of Labor and Workforce Development; and

WHEREAS, these funds will be used to provide a contingency fund to reimburse WIN for rent and other operating costs prorated to TDOL Employment Security staff occupying space at the Career Centers in Downtown Memphis (Shelby County) and Somerville, TN (Fayette County) operated by LWIA#13; and

WHEREAS, it is necessary to accept the grant funding and amend the Fiscal Year 2012 Operating Budget to establish funds for costs associated with the TDOL Employment Security staff; and

WHEREAS, it is necessary to appropriate the grant funds in the amount of Three Hundred Eighty-six Thousand, Nine Hundred Ninety-one Dollars (\$386,991.00);

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Memphis that the TDOL Employment Security Resource Sharing grant in the amount of Three Hundred Eighty-six Thousand, Nine Hundred Ninety-one Dollars (\$386,991.00) be accepted by the City of Memphis.

BE IT FURTHER RESOLVED, that the Fiscal Year 2012 Operating Budget be and is hereby amended by appropriating the Expenditures and Revenues for the TDOL Employment Security Resource Sharing Grant in the amount of Three Hundred Eighty-six Thousand, Nine Hundred Ninety-one Dollars (\$386,991.00) as follows:
