

RESOLUTION

WHEREAS, the Board of Light, Gas and Water Commissioners in their meeting of March 20, 2008 approved Change No. 5 to Contract No. 11016 Drug and Alcohol Collection Provider with True Test Collection in the funded amount of \$28,000.00, and is now recommending to the Council of the City of Memphis that it approves said Change as approved in MLGW 2008 fiscal year budget; and

WHEREAS, the project scope is to collect urine specimens and deposit the collected specimens at an approved laboratory and conduct breath alcohol test in Memphis and Shelby County, Tennessee in accordance with the Department of Transportation Drug Testing Guidelines, 49 CFR, Part 199 and Part 40 during the period of May 6, 2008 through May 5, 2009. This is the third renewal of four (4) renewal terms. The new contract value is \$130,078.00; and

NOW THEREFORE BE IT RESOLVED by the Council of the City of Memphis that there be and is hereby approved Change No. 5 to Contract No. 11016 Drug and Alcohol Collection Provider with True Test Collection in the funded amount of \$28,000.00, chargeable to the MLGW fiscal year 2008 as proposed.

The Manager of Procurement and Contracts has recommended to the Board of Light, Gas and Water Commissioners Change No. 5 to Contract No. 11016 Drug and Alcohol Collection Provider with True Test Collection in the funded amount of \$28,000.00.

The project scope is to collect urine specimens and deposit the collected specimens at an approved laboratory and conduct breath alcohol test in Memphis and Shelby County, Tennessee in accordance with the Department of Transportation Drug Testing Guidelines, 49 CFR, Part 199 and Part 40 during the period of May 6, 2008 through May 5, 2009. This is the third renewal of four (4) renewal terms. The new contract value is \$130,078.00.


The budgeted amount for 2008 is \$33,209.00; the amount spent to date is \$5,197.00 leaving a balance of \$28,012.00; and 2009 budget is to be determined.
