

RESOLUTION

WHEREAS, the Board of Light, Gas and Water Commissioners in their meeting of March 20, 2008 approved Change No. 2 to Contract No. 11097 Grounds and Landscaping Services with Environmental Landscape in the funded amount of \$74,997.00, and is now recommending to the Council of the City of Memphis that it approves said Change as approved in MLGW 2008 fiscal year budget; and

WHEREAS, the project scope is to perform landscape maintenance, irrigation and seasonal color services at the MLGW Administration Building, located at 220 South Main Street, Downtown Credit Office, 245 South Main and the Business Center, 1665 Whitten Road. This change is to renew this contract for the second of four renewal terms beginning April 5, 2008 to April 4, 2009. The new Contract value amount is \$215,353.00.

NOW THEREFORE BE IT RESOLVED by the Council of the City of Memphis that there be and is hereby approved Change No. 2 to Contract No. 11097 Grounds and Landscaping Services with Environmental Landscape in the funded amount of \$74,997.00, chargeable to the MLGW fiscal year 2008 as proposed.

The Manager of Procurement and Contracts has recommended to the Board of Light, Gas and Water Commissioners, Change No. 2 to Contract No. 11097 Grounds and Landscaping Services with Environmental Landscape to renew this Contract for the second of four renewal terms in the funded amount of \$74,997.00.

The project scope is to perform landscape maintenance, irrigation and seasonal color services at the MLGW Administration Building, located at 220 South Main Street, Downtown Credit Office, 245 South Main and the Business Center, 1665 Whitten Road. This change is to renew this contract for the second of four renewal terms beginning April 5, 2008 to April 4, 2009. The new Contract value amount is \$215,353.00.

The budgeted amount for 2008 is \$83,100.00; the amount spent to date is \$3,530.00, leaving a balance of \$4,575.00.

It was moved by Commissioner Masson, seconded by Vice Chairman Taylor and unanimously carried:
